Bridge Street Brewery is set inside a converted warehouse in Port Elizabeth's historical Baakens Valley. It was born out of the love of great beer shared by a few good mates by the father of craft beer and Master Brewer, Lex Mitchell and his team of expert brewers. We wanted to invite people into the brewing process, so we placed our bar right in the middle of the action. That's why you'll see brewers racing around, and smell the amazing hops and malts that go into making our beer while you enjoy a pizza and a pint. All our products are produced using only the finest of local and imported ingredients and an amalgam of traditional British mashing and German lagering techniques. The beers are delivered to your glass directly from our storage tanks - it doesn't get much fresher!

in a nutshell...



As you enter on the right you will see our tasting area. Come here to samples all our master brewed products, brewed right before your eyes and served by a very knowledgeable team of beer activists. Our very own brewer will take you on a guided tour of the brewery, where you will learn all about beer, brewing and the history of Bridge Street Brewery.

We sell all of our products for both takeaway and consumption on premise and have a mouth watering menu available at all times. Feel free to have a pint and a bite to eat, and enjoy the view of the beautiful Baakens Valley or just have a chat to the staff about all things beer and brewing. Tours of the brewery are held every weekend day by prior arrangement weekdays at 11:30am or 3pm, starting in the brew house with a talk about the ingredients that make up beer, then venturing all around the site, explaining the history of Bridge Street Brewery and the process of turning those ingredients into beer. The tour finishes back in the Tap Room where your tour guide will take you through a full tasting of all our different beers and our ciders too! Tastings are R42 per adult. During the week the brewery is pretty relaxed, but once the weekend hits, it turns into a buzzing celebration of beer, food and all round fun! We have an open door policy at the restaurant and deck area so everyone is welcome to walk in any time without a booking and just hang out. Bookings can be made by calling us on 041 581 0361 or sending us a message on Facebook. Upon entry, you will be greeted at the reception area by one of our waitrons, who will arrange a seat for you at an available table of your choice.

The brewery offers a variety of interesting spaces and seating areas to suit your mood or style, which are also available for booking of corporate events and parties. Whether it's at a table inside or a relaxing spot on the deck, we offer a variety of soft furnishings and cocktail style seating options to get you in the mood for an amazing brewery experience.

the tap room...



Our tap room is a multi functional space with a built in projector and pull down screen perfect for small group presentations or product launches.

It comes fully furnished with a private bar and catering area as well as a built in boardroom table. This area also boasts its own private tented deck area.

the wine room...



The Wine Room is a cosy cellar-like space, creating a warm and inviting feel. The Wine Room has its own bar area and stage which hosts the 'best' wine tastings, cocktail functions, music gigs, performing arts as well as parties and product tasting for 50 - 60 people. It is furnished with wooden cocktail tables and chairs and has access to the deck that can be covered with a bedouin tent at your own expense.




menus & catering...

Various set menus are available for your selection. We will gladly assist you with the selection of your menu according to your budget and specific food requirements. Our talented chefs are able to assist you with creating an incredible culinary experience for your guests. No food may be brought onto the premises for consumption. Should menu items not be available due to seasonal changes or supplier stock shortages, it will be replaced with a suitable substitute product. All menu prices are subject to change without prior notice due to supplier prices and seasonal availability.

Dietary requirements will be catered for by prior arrangement only. The cost of special dietary meals will be amended according to meal requirements and stock availability.

bar & beverage services...

Bridge Street Brewery is equipped with a fully licensed bar operating by prior arrangement only. We offer cash, limited or full open bar option services. A list of available beverages, welcoming drinks, wine list and bar items are available on request. Should you prefer to bring your own wines and sparkling wines, the following will apply: A Limit of 2 bottles of wine and two bottles of sparkling wine per 10 guests. A corkage fee of R40.00 will be applicable. A 10% service fee will be added to the total sales, should the bar be operating on a tab.

terms & conditions...

The following terms & conditions are set in place to ensure that the administration and execution of your function will meet your expectations.

confirmation...

The venue hiring fee serves as a deposit for your event. Bookings are only considered confirmed once Bridge Street Brewery has received both the completed confirmation contract and the Venue Hire Fee. The Cancellation Policy will apply as soon as we have received the confirmation contract. This quotation is valid for 7 working days. Should there be another enquiry for your requested date before your quotation period expires, we will notify you. Should you wish to make use of our venue on a public holiday, additional costs may occur. Please consult with your coordinator in this regard.

payment...

On receipt of your signed confirmation sheet, we will send you a deposit invoice for payment within 5 working days. Should Bridge Street Brewery not receive proof of the deposit payment within 7 working days of the date appearing on the invoice, the booking will be considered cancelled. The cancellation policy will automatically come into effect thereafter. All fixed costs are due 5 working days prior to commencement of your event. An invoice with all additional costs will be sent to you after the function, and the account should be settled within 7 working days from the date appearing on the invoice. A 7% admin fee will be added to the account / invoice for payments made with a credit card.

damages or loss...

Whilst every precaution will be taken to ensure the safeguarding of your belongings, Bridge Street Brewery will not be liable for loss or damage to any property whatsoever (décor, gifts, valuables, banners, training material etc). We recommend that all personal and valuable property be removed directly after the function. Should the Bridge Street Brewery buildings, surrounding gardens, décor, furniture or any goods of the venue be lost or damaged in any way during the set-up, duration or breakdown of the event, the client shall be held responsible and will be billed accordingly. These costs will be added to your final invoice. Bridge Street Brewery, its employees or any person employed at any function will not be held liable for any loss or injury to persons, due to negligence or any other cause whatsoever.

underage guests...

All guests under the age of 18 are required to be with their legal parent/guardian at all times for them to be able to take part in the function.

cancellation policy...

Our cancellation policy is based on reserving a specific date and venue. Once we receive written confirmation of the event, we ensure availability according to your needs which limits its availability to other clients and business. Should you cancel your event after Bridge Street Brewery has received confirmation of the date requested (confirmation contract, e-mail or any written confirmation) the following cancellation fees will be applicable: A cancellation of 10 days or more after receipt of confirmation will result in a 50% liability of the venue hire fee quoted.. Should your event be cancelled or numbers change within 7 working days or less prior to your event, you will be liable for the payment of 100% of the Venue Hire Fee and catering costs according to the details stated on latest updated quote received from Bridge Street Brewery. Cancellations will only be accepted in writing from an authorized signatory. Please ensure receipt of cancellation with your function coordinator. Kindly note that Bridge Street Brewery reserves the right to cancel your function should all fixed costs not be paid working days prior to commencement of your event.
